Sheriff's Report

February 23, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On February 15th, a deputy was dispatched to a residence in the 2200 block of County road 2180 in reference to a 911 call concerning a physical altercation between juvenile sisters. The deputy spoke with the step-mother and both juveniles. The father of the girls transported the juveniles to the Randolph County Juvenile Office where they were released to the Juvenile Office for further disposition.

On February 15th at 6:24 pm, a deputy was dispatched to a location on Highway 24, east of County Road 1210 in reference to an injured deer lying near the roadway. The deputy located the animal, euthanized it and removed it from the roadway. No further action taken.

On February 16th at 12:43 am, a deputy received a call from Howard County authorities concerning an individual who had an outstanding Randolph County warrant that was hiding in a residence on Highway U in Howard County. Deputies from Howard and Randolph counties and Troopers from the Missouri State Highway Patrol proceeded to the residence, located the wanted suspect and took him into custody. The suspect was transported to the Randolph County Jail.

On February 16th, a deputy was dispatched to a residence in the 3700 block of Highway 24 in reference to a structure fire. The deputy provided traffic control until the fire was extinguished and his service was no longer needed.

On February 17th at 9:30 pm a deputy received a report of a loud suspicious vehicle driving around the Renick Park. The deputy patrolled the area without locating any loud vehicles.

On February 17th at 9:30 pm, a deputy overheard Moberly Police Department radio traffic concerning a white passenger vehicle that was involved in a hit and run accident. The deputy observed a vehicle matching the description traveling east on Highway EE. The deputy attempted to stop the vehicle but the driver attempted to flee. After a short chase, the vehicle stopped and the driver was taken into custody. The subject was turned over to Moberly Police Department.

On February 18th at 6:20 pm, deputies were dispatched to a residence in the 100 block of Powell street in Jacksonville in reference to a disturbance. One of the parties told the deputy who was involved in the disturbance. The deputy knew that the female party had outstanding warrants. The female subject was located hiding in the residence. She was taken into custody and transported to the Randolph County Jail.

On February 19th at 12:39 am, a deputy was dispatched to a location on Highway 63, concerning a male subject who was walking on the shoulder, north bound. The deputy located the individual and identified him. The deputy noted that the individual was extremely intoxicated. The subject was subject was transported to his residence and left with family members.

On February 19th at 8:16 pm, a deputy was dispatched to a location in the 1100 block of County Road 1945 in reference to a fire alarm sounding. Upon arrival, it was discovered that the alarm was false. No further action taken.

The vehicle was described as being a white SUV. The deputy patrolled the area without locating any vehicles matching the description given.

On February 21st at 8:42 am, a deputy was dispatched to a location on Highway B west of Higbee in reference to a stranded motorist. Upon arrival, the deputy noted that the vehicle had a flat tire. The deputy assisted in changing the tire and the vehicle was removed from the roadway.

On February 22nd at 12:00 pm, a deputy was dispatched to County Road 1775 for a suspicious vehicle. The complainant reported that the would slowly drive down the road and periodically stop. The vehicle was described as being a rusty red colored compact passenger vehicle. The deputy patrolled the road without locating any vehicles matching the description given.

On February 13th, 55-year old James D Gaines of Moberly was served two Randolph County warrants. Warrant one for failure to appear on an ordinance violation of operated vehicle on highway without a valid or no license. Bond set at \$150 cash only. Warrant two for failure to appear on an ordinance violation of illegal/improper turning. Bond set at \$100 cash only. Gaines posted the required bond and released.

On February 13th, 28-year old Emily Janet Gibson of Moberly was served two Randolph County warrants. Warrant one for a probation violation on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$20,000 cash only. Warrant two for a probation violation on two class B felony charges of distribute/deliver/manufacture/produce or attempt to or possess with intent to distribute/deliver/manufacture/produce a controlled substance. Bond set at \$20,000 cash only. Gibson was unable to post the required bond and remains incarcerated.

On February 13th, 33-year old James Allen Acklin of Moberly was served two Randolph County warrants. Warrant one for a probation violation on a class B felony charge of distribute/deliver/manufacture/produce or attempt to or possess with intent to distribute/deliver/manufacture/produce a controlled substance. Bond set at \$20,000 cash only. Warrant two for a probation violation on a class C felony charge of assault – 2nd degree. Bond set at \$25,000 cash or surety. Acklin remains in the Randolph County Jail in lieu of the required bond.

On February 14th, 25-year old Bradley E. Enyart of Moberly was served a Randolph County warrant on a class B felony charge of delivery or possession of a weapon at county/private jail/correctional center. Bond set at \$40,000 cash only. Enyart was unable to post the required bond and remains incarcerated.

On February 15th, 51-year old Richard Lee Jordan of Columbia was served a Randolph County warrant for a probation violation on a class C felony charge of unlawful possession of a firearm. Bond set at \$7,500 cash or surety. Jordan posted the required bond and released.

On February 15th, 48-year old Humberto Jose Gutierrez Jr. of Moberly was served a Randolph County warrant on a class B felony charge of driving while intoxicated – habitual offender. Bond set at \$25,000 cash only. Gutierrez remains in the Randolph County Jail in lieu of the required bond.

On February 16th, 39-year old William J. Stefl of Edina was served a Randolph County warrant for failure to appear on a class D felony charge of driving while revoked/suspended. Bond set at \$25,000 cash or surety. Stefl remains in the Randolph County Jail in lieu of the required bond.

On February 18th, 28-year old Marybeth Ashley Baggett of Jacksonville was served three warrants. Warrant one from Randolph County for failure to appear on an ordinance violation of open container. Bond set at \$150 cash only. Warrant two from Randolph County for failure to appear on an ordinance violation of trespass. Bond set at \$200 cash only. Warrant three from Macon County for failure to appear on a class B misdemeanor charge of trespass – 1^{st} degree. Bond set at \$300 cash only. Baggett remains in the Randolph County Jail in lieu of the required bond.

On February 20th, 37-year old Jessica M. Cunningham of rural Moberly was served a Randolph County warrant on a class E felony charge of non-support, total arrears in excess of 12 monthly payments due under order of support. Bond set at \$500 cash only. Cunningham posted the required bond and released.

On February 21st, 28-year old Andrea Derae Williams of Moberly was served a Randolph County warrant for failure to appear on a class D misdemeanor charge of operated motor vehicle on highway without a valid license – 1st offense and a class C misdemeanor charge of fail to stop for steady red signal at crosswalk/stop line/point nearest intersection. Bond set at \$300 cash only. Williams was released on her own recognizance by the court.

On February 21^{st} , 54-year old Raymond Head of LaPlata was served a Randolph County warrant on a class E felony charge of domestic assault – 3^{rd} degree. Bond set at \$5,000 cash or surety. Head remains in the Randolph County Jail in lieu of the required bond.

On February 21st, 36-year old Amy Natasha Phillips of Moberly was served a Randolph County warrant for a probation violation on a class D felony charge of leaving the scene of a motor vehicle accident—injury, property damage, or 2nd offense and a class B misdemeanor charge of driving while intoxicated – alcohol. Bond set at \$10,000 cash only. Phillips remains in the Randolph County Jail in lieu of the required bond.

On February 21st, 48-year old Troy Lee Cunningham of Moberly was served a Randolph County warrant on a class B felony charge of burglary 1st degree and a class E felony charge of domestic assault – 3rd degree. Bond set at \$25,000 cash only. Cunningham remains in the Randolph County Jail in lieu of the required bond.

On February 21st, 52-year old Anthony Michael White was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E felony charge of keeping or maintaining a public nuisance. Bond set at \$10,000 cash or surety. White remains in the Randolph County Jail in lieu of the required bond. On February 21st, 26-year old Aaron James Kipper was served a Randolph County warrant for a probation violation on a class B misdemeanor charge of property damage 2nd degree. Bond set at \$700 cash only. Kipper posted the required bond and released.

On February 21, 29-year old Julius Cureton was served a Randolph County warrant for failure to appear on a class B felony charge of distribute/deliver/manufacture/produce or attempt to or possess with intent of distribute/deliver/manufacture/produce a controlled substance. Bond set at \$100 cash only. Cureton posted the required bond and released.

On February 21st, 47-year old Jason Andrew Henage was served a Randolph County warrant on a class D felony charge of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$10,000 surety or 10% cash. Henage posted the required bond and released.
