## Sheriff's Report

March 30, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On March 22, 2018 at 5:00 pm, a deputy was dispatched to a residence in the 3200 block of County road 2210 in reference to a report of property damage. The deputy contacted the complainant who reported that someone had broken out the front driver-side window on his Dodge Caravan vehicle. Nothing was found disturbed in the vehicle. The investigation continues.

On March 22, 2018 at 6:15 pm, a deputy with the assistance of a Missouri State Trooper, responded to a location on Highway 3, north of Clifton Hill in reference to a possible suicidal subject. The individual was located and interviewed. The subject did not display indicators of self-harm. The subject was transported to his residence and left in the care of a friend. No further action taken.

On March 22, 2018 at 11:00 pm, a deputy was dispatched to a residence in 100 block of Main Street in Yates in reference to an individual who was burning tires. Upon arrival, the deputy spoke to the suspect who advised that he was burning tires. The deputy advised that it was unlawful to burn tires and ordered him to extinguish the fire. The suspect complied with the order.

On March 23, 2018 at 8:00 am, deputies were dispatched to a business on the 5600 block of Highway F in reference to a report of property damage. Contact was made with an employee who reported that someone had tampered with a security gate causing it not to open properly. The investigation continues.

On March 24, 2018 at 12:31 am, a deputy was dispatched to a location on County Road 2660 in reference to a suspicious vehicle. The deputy located the vehicle and found it unoccupied. The owner of the property arrived. The deputy and the owner started to search the property when the female owner of the vehicle was located and advised that her vehicle was experiencing mechanical problems. The owner agreed to assist the vehicle owner and get her on her way.

On March 25, 2018 at 1:30 am, a deputy was dispatched to a residence in the 200 block of Railroad Street in Higbee in reference to a theft. The complainant reported that while his

vehicle was parked at his residence, someone entered his vehicle and stole a checkbook, a Slide brand flashlight, a pair of Simmons 10x50 binoculars and an undetermined amount of loose change. The investigation continues.

On March 25, 2018 at 4:44 pm, a deputy was given information that a male subject in a red 1995 Chevrolet pickup was enrooted to Huntsville to do bodily harm to someone. While patrolling Huntsville, the deputy located a vehicle matching the one given. The driver was contacted and interviewed. The subject was searched for weapons. No weapons were located however a controlled substance was discovered on the suspect. The suspect was arrested and transported to the Randolph County Jail. A copy of the report has been forwarded to the Randolph County Prosecuting Attorney for review and formal action.

On March 27, 2018 at 1:04 am, a deputy was dispatched to the railroad crossing in Clifton Hill in reference to an individual being hit by a train. Upon arrival, the deputy met with the conductor who reported that they observed a male subject walking on the tracks. The emergency brakes were deployed. The conductor departed the train and walked the tracks, finding the male subject setting on the tracks unharmed. The deputy interviewed the subject. The subject could not provide the deputy any information other than his name. The subject was transported to MRMC by RCAD for observation. No further action taken.

On March 27, 2018 at 1:25 pm, a deputy received a burglary report from an individual who resides on County Road 1223. The complainant reported that she departed her residence in December and when she returned, she noticed that entry had been forced into her residence and a 40" LG brand television, a Samsung Blu-ray DVD player, a Nescafé coffee maker, 2 – Dish satellite receivers and several smaller items. Photographs were taken at the scene. The investigation continues.

On March 27, 2018 at 9:19 pm, a deputy was dispatched to the location on Highway B and 63 in reference to an injured deer lying on the Highway. The deputy located the animal and found it deceased. The animal was removed from the road and the deputy resumed patrol.

On March 30, 2018 at 2:47 am, a deputy was dispatched to a business in Huntsville in reference to an alarm sounding. Upon arrival, the deputy met with an employee who advised that they entered the wrong security code and triggered the alarm. The deputy did not observe anything unusual. No further action taken.

On March 23<sup>rd</sup>, Tyler Henry Bennett 31 of Moberly was served a Randolph County warrant on a class E felony charge of delivery of 35 grams or less of Marijuana or Synthetic Cannabinoid and a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or synthetic cannabinoid. Bond set at \$10,000 cash or surety. Bennett posted the required bond and released.

On March 23<sup>rd</sup>, Tyler Wayne Kelsay 24 of Moberly was served a Randolph County warrant on a class E felony charge of delivery of 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$5,000 cash or surety. Kelsay posted the required bond and released.

On March 23<sup>rd</sup>, Bailey Brianna Coleman 22 of Huntsville was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$20,000 cash only. Coleman remains in the Randolph County Jail in lieu of the required bond.

On March 23<sup>rd</sup>, Carl Lee Bode 36 of Moberly was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$20,000 cash only. Bode remains in the Randolph County Jail in lieu of the required bond.

On March  $23^{rd}$ , Curtis Anthony Pearce 33 of Moberly was served a Randolph County warrant on a class A misdemeanor charge of domestic assault –  $4^{th}$  degree –  $1^{st}$  or  $2^{nd}$  offense. Bond set at \$2,500 cash or surety. Pearce posted the required bond and released.

On March 23<sup>rd</sup>, Joshua R. Apel 33of rural Clark was served a Randolph County warrant on a class E felony charge of resisting/interfering with arrest for a felony. Bond set at \$2,500 cash or surety. Apel remains in the Randolph County Jail in lieu of the required bond.

On March 23<sup>rd</sup>, James Ray Fainter Jr.36 of Renick was served a Randolph County warrant on a class E felony charge of damage to jail/jail property. Bond set at \$25,000 cash only. Fainter remains in the Randolph County Jail in lieu of the required bond.

On March 26<sup>th</sup>, Matthew Areel Graves 24 of Moberly was served a Randolph County warrant on a class A felony charge of assault 1<sup>st</sup> degree or attempt – serious physical injury and an unclassified felony charge of armed criminal action. Bond set at \$100,000 cash only. Graves remains incarcerated.

On March 26<sup>th</sup>, Joshua Lee Jenkins 30 of rural Moberly was served a Randolph County warrant on a class B felony charge of burglary 1<sup>st</sup> degree and a class E felony charge of assault 3<sup>rd</sup> degree. Bond set at \$50,000 cash only. Jenkins remains incarcerated.

On March 26<sup>th</sup>, Royce Edward Coachman 39 of Columbia was served a Randolph County warrant for failure to appear on a class B misdemeanor charge of failure to register a motor vehicle. Bond set at \$200 cash only. Coachman posted the required bond and released.

On March 26<sup>th</sup>, Jessica Leeanne Kirkpatrick 21 of Sedalia was served a Randolph County warrant for failure to appear on a class D misdemeanor charge of stealing – value less than \$150 and no

prior stealing offenses. Bond set at \$500 cash or surety. Kirkpatrick posted the required bond and released.

On March 26<sup>th</sup>, Robert Lee Howe Jr. 35 of rural Moberly was served a Randolph County warrant on a class A misdemeanor charge of domestic assault  $-4^{th}$  degree  $-1^{st}$  or  $2^{nd}$  offense. Bond set at \$2,000 cash or surety. Howe posted the required bond and released.

On March 26<sup>th</sup>, Ramona Juanita Green 44 of Moberly was served a Randolph County warrant for failure to appear on a class B misdemeanor charge of failure to register a motor vehicle. Bond set at \$200 cash only. Green posted the required bond and released.

On March 26<sup>th</sup>, Amanda R. Barney 21 of Moberly was served a Randolph County warrant on two class D felony charges of accessory possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid, a class E felony charge of accessory keeping or maintaining a public nuisance and a class D felony charge of accessory endangering the welfare of a child – creating substantial risk –  $1^{st}$  degree –  $1^{st}$  offense – no sexual contact. Bond set at \$20,000 cash or surety. Barney posted the required bond and released.

On March 26<sup>th</sup>, Coleman Ray Brown 22 of Huntsville was served a Randolph County warrant for failure to appear on a class A misdemeanor charge of stealing. Bond set at \$1,000 cash or surety. Brown posted the required bond and released.

On March 27<sup>th</sup>, Tamarra Shante Jones 20 of Springfield was served a Randolph County warrant for failure to appear on a class E felony charge of unlawful use of a weapon – exhibiting. Bond set at \$20,000 cash only. Jones was placed on probation and released by the court.

On March 27<sup>th</sup>, Melvin Richard Copeland Jr. 20 of rural Huntsville was served a Randolph County warrant for a probation violation on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class D misdemeanor charge of operate vehicle on highway without a valid license -1<sup>st</sup> offense. Bond set at \$7,500 cash or surety. Copeland remains in the Randolph County Jail in lieu of the required bond.

On March 27<sup>th</sup>, Chris Jai Smith 23 of Moberly was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$10,000 cash or surety. Smith remains in the Randolph County Jail in lieu of the required bond.

On March 27<sup>th</sup>, Karen Eugenia Harlan 53 of Moberly was served a Randolph County warrant for a probation violation on a class C felony charge of theft/stealing of property or services of \$500

or more but less than \$25,000. Bond set at \$250 cash only. Harlan posted the required bond and released.

On March 28, 2018, Kevin Loyd White 51 of Moberly was served a Randolph County warrant for a probation violation on a class B felony charge of distribute/deliver/manufacture/produce or attempt to or possess with intent to distribute/deliver/manufacture/produce a controlled substance. Bond set at \$25,000 cash only. White remains in the Randolph County Jail in lieu of the required bond.

On March 28, 2018, Christa Lynn Harris 31 of Bevier was served a Randolph County warrant for failure to appear on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$2,500 cash only. Harris remains in the Randolph County Jail in lieu of the required bond.

On March 28, 2018, Christopher William Wright 28 of Moberly was served a Randolph County warrant for a probation violation on a class D felony charge of domestic assault  $-2^{nd}$  degree. Bond set at \$2,500 cash or surety. Wright remains in the Randolph County Jail in lieu of the required bond.

On March 29, 2018, Claudia Isabel Johnson 31 of rural Moberly was served a Randolph County warrant for failure to appear on an ordinance violation of operated vehicle on highway without a valid or no license. Bond set at \$225 cash only. Johnson posted the required bond and released.

On March 29, 2018, James Tracy Sullivan 46 of rural Moberly was served a Randolph County warrant for failure to appear on a class E felony charge of domestic assault  $-3^{rd}$  degree. Bond set at \$10,000 cash only. Sullivan remains in the Randolph County Jail in lieu of the required bond.

On March 29, 2018, Tracy Lynn Cannon 36 of Springfield was served a Randolph County warrant for a probation violation on a class C felony charge of possession of a controlled substance except 35 grams or less of Marijuana. Bond set at \$20,000 cash only. Cannon remains in the Randolph County Jail in lieu of the required bond.
