

Sheriff's Report

April 27, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On April 19th at 5:05 pm, a deputy was dispatched to a property on Holman Street in Clifton Hill in reference to a report of trespass. Upon arrival, the deputy met with a male subject who advised that he had permission from the owner to be on the property. Contact was made with the owner who confirmed the subjects claim. No further action taken.

On April 22nd at 5:10 pm, a deputy was dispatched to a location in the 1800 block of County Road 2435 in reference to possible shots fired. Upon arrival, the deputy met with the complainant who reported that individuals in a black Chevrolet pickup discharged a firearm. The deputy with the assistance of a Missouri State Trooper searched for the suspect vehicle to no avail.

On April 24th at 11:35 am, a deputy was dispatched to a disturbance at Huntsville City Hall. Upon arrival, contact was made with the suspect who advised that he wanted to file a complaint with the Chief but the Chief was not available. Officers were able to calm the suspect and advised him how to properly file a complaint.

On April 24th, a deputy was dispatched to the 600 block of Huntsville Ave., in Huntsville to assist a Huntsville Police Office with taking an individual into custody. Upon arrival, the deputy observed the Huntsville officer and a civilian in a physical altercation with the individual. The subject was restrained and transported to the Randolph County Jail.

On April 24th at 10:20 pm, a deputy was dispatched to a location on Highway 63, near Renick in reference to a rollover accident. The deputy provided traffic control until the investigation completed and area cleared.

On April 25th at 4:00 pm, a deputy was dispatched to a location near the intersection of Highways AA and B in reference to horses on the Highway. The owner of the horses was located. The owner and neighbors corralled the animals and the animals were trailered back to their pasture.

On April 20th, Thomas Lewellen Miller Jr., 22 of Moberly, was served two Randolph County warrants. Warrant one on a class C felony charge of deliver of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$25,000 cash only. Warrant two for failure to appear on an infraction of driver/front seat passenger failed to wear properly adjusted/fastened safety belt. Bond set at \$100 cash or surety. Miller was released on his own recognizance by the court.

On April 20th, Kaden Elija Lockwood, 20 of Columbia, was served a Randolph County warrant on a class D felony charge of assault – 3rd degree – special victim. Bond set at \$5,000 cash only. Lockwood remains in the Randolph County Jail in lieu of the required bond.

On April 23rd, Kayleigh Elaine Atkinson, 31 of Salisbury, was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$2,500 cash or surety. Atkinson posted the required bond and released.

On April 23rd, Trevor Lee Dennis, 29 of rural Moberly, was served a Randolph County warrant on a class D felony charge of odometer fraud – 2nd degree. Bond set at \$5,000 cash or surety – 10% cash allowed. Dennis posted the required bond and released.

On April 23rd, Sharon Lynn Graf, 33 of Columbia was served two Randolph County warrants. Warrant one for failure to appear on a class D misdemeanor charge of owner operated motor vehicle without maintaining financial responsibility – 1st offense. Bond set at \$250 cash only. Warrant two for failure to appear on an infraction of driver/front seat passenger failed to wear a properly adjusted/fastened safety belt. Bond set at \$50 cash only. Graf posted the required bond and released.

On April 23rd, Cristian (Christian) Abel Alvizo, 26 of Moberly was served a Randolph County warrant on a class B misdemeanor charge of driving while intoxicated. Bond set at \$2,500 cash or surety. Alvizo posted the required bond and released.

On April 23rd, Todd Phillip Mueller, 39 of Moberly was served a Randolph County warrant on four class D felony charges of forgery. Bond set at \$10,000 cash only. Mueller was released on his own recognizance by the court.

On April 23rd, Chadwick Michael Mattingly, 26 of Mexico was served a Randolph County warrant for failure to appear on an infraction of driver/front seat passenger failed to wear properly adjusted/fastened safety belt. Bond set at \$50 cash only. Mattingly posted the required bond and released.

On April 23rd, Jarvy Gil Vidal, 52 of Rialto, CA was served a Randolph County warrant on a class E felony charge of leaving the scene of an accident – physical injury. Bond set at \$5,000 cash or surety. Vidal posted the required bond and released.

On April 23rd, Melissa Diane Logan, 30 of Moberly was served a Randolph County warrant on a class B misdemeanor charge of driving while intoxicated. Bond set at \$2,500 cash or surety. Logan posted the required bond and released.

On April 23rd, Taylor Elizabeth Welch, 19 of Moberly was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid. Bond set at \$10,000 cash or surety. Welch posted the required bond and released.

On April 23rd, Tabitha Shaun Bivins, 38 of Moberly was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E felony charge of keeping or maintaining a public nuisance. Bond set at \$10,000 cash only. Bivins remains in the Randolph County Jail in lieu of the required bond.

On April 24th, Timothy Ray Coonce, 38 of Moberly was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E felony charge of keeping or maintaining a public nuisance. Bond set at \$10,000 cash only. Coonce remains in the Randolph County Jail in lieu of the required bond.

On April 24th, Cheyenne Sioux Hartzing, 18 of Columbia was served a Randolph County warrant for failure to appear on an ordinance violation of operated motor vehicle without maintaining financial responsibility. Bond set at \$135.50 cash only. Hartzing posted the required bond and released.

On April 24th, Tyler Joel Ahrens, 19 of Moberly was served a Randolph County warrant for failure to appear on an ordinance violation of driving while revoked or suspended. Bond set at \$300 cash only. Ahrens posted the required bond and released.

On April 24th, Rusty L. Camp, 42 of Madison was served a Randolph County warrant for failure to appear on an infraction of driver/front seat passenger failed to wear properly adjusted/fastened safety belt. Bond set at \$50 cash only. Camp remains in the Randolph County Jail in lieu of the required bond.

On April 24th, Joseph Ray Bell of Kirbyville, MO was served two Randolph County warrants. Warrant one for a probation violation on a class C felony charge of burglary – 2nd

degree. Bond set at \$10,000 cash only. Warrant two for a probation violation on a class C felony charge of burglary – 2nd degree, a Class C felony charge of receiving stolen property and a class A misdemeanor charge of theft/stealing of property or services less than \$500. Bond set at \$10,000 cash only. Bell remains in the Randolph County Jail in lieu of the required bond.

On April 24th, Claudia Ann Galegor, 40 of Moberly was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$10,000 cash or surety. Galegor remains in the Randolph County Jail in lieu of the required bond.

On April 25th, Deseray Lynn Woods, 32 of Moberly was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$7,500 cash or surety. Woods remains in the Randolph County Jail in lieu of the required bond.

On April 26th, Corey Gregory Gabelman, 30 of Moberly was served two Randolph County warrants. Warrant one for a probation violation on two class C felony charges of assault/attempted assault – law enforcement, corrections officer, highway worker, utility worker, or probation and parole – other than deadly weapon or dangerous instrument – physical injury – 2nd degree. Bond set at \$25,000 cash only. Warrant two for a probation violation on a class B felony charge of distribute/deliver/manufacture/produce or attempt to or possess with intent to distribute/deliver/manufacture/produce a controlled substance. Bond set at \$25,000 cash only. Gabelman remains in the Randolph County Jail in lieu of the required bond.

On April 26th, William Michael Oliver, 66 of Moberly was served a Randolph County warrant on a class E felony charge of unlawful use of a weapon – exhibiting and a class E felony charge of resisting/interfering with arrest for a felony. Bond set at \$7,500 cash only. Oliver remains in the Randolph County Jail in lieu of the required bond.
