Sheriff's Report

May 25, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On May 18th, a deputy was dispatched to a residence on County Road 1315 in reference to a burglary. The complainant reported that someone forced entry into the residence and stole items. Photographs were taken at the scene. The investigation continues.

On May 21st, a Moberly resident was served an order for 96-hour detention, evaluation and treatment. The subject was transported to Missouri University Psychiatric Center in Columbia without incident.

On May 21st, a deputy was dispatched to a location on County Road 2930 in reference to a theft. The complainant reported that he had a skid loader with a tree-grasp in the area so that he could do some work in the area. While he was away from the machine, someone stole the tree-grasp. Photographs were taken at the scene. The investigation continues.

On May 21st, a deputy was dispatched to the intersection of Highways 24 and 3 North in reference to cattle on the roadway. The deputy patrolled the area but did not observe any cattle out of confinement.

On May 22nd, a deputy was contacted by a subject who wanted to report a suspicious incident. The complainant reported that she hired a subject to work on her vehicle. After the subject failed to return the vehicle, the complainant called the mechanic shop the subject was supposed to be employed by and learned that he did not work there. On May 22nd, a deputy contacted a Higbee resident concerning a theft. The complainant reported that someone stole the license plate from her 2000 Chevrolet Malibu. The stolen plate has been entered into MULES.

On May 23rd, a deputy received a report of an individual who refused to return borrowed property. The complainant reported that she loaned a subject a cellular phone and now he

refuses to return the phone. The deputy is attempting to locate the suspect for questioning. The investigation continues.

On May 23rd, a deputy was dispatched to a location on County Road 2230 in reference to a report of trespass. The complainant reported that young male subjects were riding an ATV in his hayfield. The deputy located the subjects and advised them no to ride on the complainant's property. The subjects advised that they would.

On May 23rd, a deputy was dispatched to a residence in the 400 block of South Main Street in Huntsville in reference to a suspicious person. The complainant reported that a male subject with long hair, wearing blue jeans and a grey shirt was walking near the complainant's residence. The deputy searched the area without locating anyone matching the description provided.

Bond set at \$141.50. Warrant two for failure to appear on a class A misdemeanor charge of stealing leased or rented property. Bond set at \$20 cash only. Miller posted the required bond and released.

On May 21st, Ryan Bo Stark of Mercer, MO was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$15,000 cash only. Stark remains in the Randolph County Jail in lieu of the required bond.

On May 21st, Jace Michael Scot Palmer of Moberly was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E felony charge of delivery of 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$25,000 cash or surety. Palmer posted the required bond and released.

Bond set at \$20,000 cash or surety. Gray remains in the Randolph County Jail in lieu of the required bond.

On May 22nd, Robert Wayne Hess Jr. of Moberly was served a Randolph County warrant for failure to appear on a class A misdemeanor charge of violation of order of protection for adult. Bond set at \$1,000 cash or surety. Hess posted the required bond and released.

Kitson remains in the Randolph County Jail in lieu of the required bond.

Bond set at \$10,000 cash only. Smith remains in the Randolph County Jail in lieu of the Required bond.

Bond set at \$4,950 cash only. Shepherd received a bond reduction, bond was posted and subject released.

Bond set at \$4,500 cash only. Downing remains in the Randolph County Jail in lieu of the required bond and released.

Warrant one for a probation violation on a class C felony charge of possession of a controlled substance except 35 grams or less of Marijuana. Bond set at \$25,000 cash only. Warrant two for a probation violation on two class C felony charges of possession of a controlled substance except 35 grams or less of Marijuana. Bond set at \$25,000 cash only. Kitchen remains in the Randolph County Jail in lieu of the required bond.
