Sheriff's Report

June 15, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On June 7th, a deputy was dispatched to a residence on County Road 2265 in reference to checking the wellbeing of an individual. Upon arrival, the deputy met with the individual. The individual advised that he ex-husband was in the residence and threatened to shoot her. The deputy requested assistance. Officers from Moberly Police Department and the Missouri State Highway Patrol responded. A search was made of the residence. No firearms were located. The individual advised that she would spend the night at another location. No further action taken.

On June 7th, a deputy responded to a residence on Highway AA in reference to a residential alarm sounding. Upon arrival, the deputy found the residence to be secure and undisturbed. No further action taken.

On June 8th, a deputy was dispatched to a residence on County Road 2445 in reference to a report of trespass. The complainant reported that his Grandson who was not welcome on the property was found sleeping in a trailer that was on the property. The deputy contacted the suspect and advised him to vacate the property. The suspect complied and departed the property.

On June 8th, a deputy was dispatched to a location on Highway 63, south of Jacksonville in reference to a vehicle striking a deer. The deputy located the vehicle and occupants. The deputy inquired if medical assistance was needed. The occupants declined. The occupants advised the deputy that they had assistance enroute. The deputy removed the deceased animal from the roadway and departed the area.

On June 8th, a deputy was requested to respond to a residence on Highway JJ to keep the peace while the complainant retrieved personal property at his residence, due to problems with his estranged wife. The property was gathered and the complainant departed.

On June 9th, a deputy was dispatched to the Veterans Cemetery in reference to an alarm sounding. Upon arrival, the deputy found all buildings secure and undisturbed. No further action taken.

On June 9th, a deputy was dispatched to a residence in the 500 block of E. Elm Street in Huntsville in reference to keeping the peace while one party retrieved personal property from the residence. The property was gathered without incident. No further action taken.

On June 9th, a deputy was dispatched to a residence in the 200 block of Morris Street in reference to a burglary. The deputy arrived at the residence, finding it vacant, secured and undisturbed. No further action taken.

On June 10th, a deputy was dispatched to Casey's in Huntsville in reference to an alarm sounding. Upon arrival, the deputy met with an employee who advised that the wrong security code was entered into the system causing it to trigger. No further action taken.

On June 10th, a deputy was dispatched to a location on Highway BB in reference to three females walking on the Highway. The deputy patrolled the entire Highway without locating any pedestrians.

On June 11th, a deputy received a possible theft report from a Moberly resident. The complainant reported that his ex-girlfriend refused to return his personal property unless he paid her money. The deputy is attempting to contact the suspect to interview her. The investigation continues.

On June 11th, a deputy was dispatched to a location on Highway 63, south of Cairo in reference to assisting the Missouri State Highway Patrol with traffic control at the scene of a motor vehicle accident. The deputy remained on scene until the investigation was complete and the area cleared.

On June 12th, a deputy was dispatched to a business east of Moberly on Highway 24 concerning an alarm sounding. Upon arrival, the deputy met with several employees who advised that the wrong security code was entered into the alarm system and triggered the alarm. No further action taken.

On June 12th, a deputy was dispatched to a residence in the 4000 block of Highway U in reference to a domestic disturbance. The complainant reported that she and her husband were involved in a verbal argument and when she attempted to leave the residence, her husband threatened to burn her personal property. While interviewing the husband, he denied the claim. The complainant gathered some property and departed the residence without incident.

On June 13th, while traveling on Highway 63, a deputy observed a vehicle being operated with expired license plates. The deputy initiated a traffic stop and identified the driver and occupant. When the deputy advised the driver why he pulled her over, she stated that she had

received a few tickets for the same violation. The deputy issued the driver a summons for failing to register a motor vehicle. No further action taken.

On June 14th, a deputy was dispatched to a residence in the 1200 block of County Road 1232 in reference to a domestic assault. Upon arrival, the deputy met with all parties at the residence. The victim reported that another female struck her in the head with a closed fist and pulled her hair. When the deputy interviewed the 2nd female, she admitted to the claim. The suspect was arrested and transported to the Randolph County Jail.

On June 8th, Trevor Dorsey Marshall of Moberly was served a Randolph County warrant for failure to appear on a class D felony charge of operated vehicle on highway without a valid license – 3rd and subsequent offense. Bond set at \$5,000 surety or 10% cash allowed. Marshall posted the required bond and released.

On June 8th, Julie Marie Dickinson of Columbia was served two Randolph County warrants. Warrant one on a class E felony charge of passing bad checks. Bond set at \$750 cash only. Warrant two for failure to appear on a class E felony charge of passing bad checks. Bond set at \$500 cash only. Dickinson was released on her own recognizance by the court.

On June 8th, Anthony Edward Nash of Moberly was served two Randolph County warrants. Warrant one for failure to obey a judge's order on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$10,000 cash only. Warrant two for failure to obey a judge's order on a class C Felony charge of delivery of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$20,000. Nash remains in the Randolph County Jail in lieu of the required bond.

On June 8th, Ricco Valentino Marshall of Moberly was served two Randolph County warrants. Warrant one for failure to obey a judge's order on a class D felony charge of domestic assault – 2nd degree. Bond set at \$10,000 cash only. Warrant two for failure to obey a judge's order on a class B felony charge of burglary – 2nd degree. Bond set at \$10,000 cash only. Marshall remains in the Randolph County Jail in lieu of the required bond.

On June 9th, Jason M. Gray of Columbia was served a City of Moberly warrant for failure to appear on an ordinance violation of exceeded the posted speed limit by 6 to 10 miles per hour over and an ordinance violation of driver of motor vehicle failed to wear properly adjusted/fastened safety belt. Bond set at \$125 cash only. Gray was released on his own recognizance by the court.

On June 11th, Shawnteil Frank Tiger of Moberly was served a Randolph County warrant on a class E felony charge of driving while revoked/suspended. Bond set at \$2,000 cash or surety. Tiger posted the required bond and released.

On June 11th, Christopher Lee Parizo of Moberly was served a Randolph County warrant for failure to appear on a class E felony charge of resisting/interfering with arrest for a felony and a class D felony charge of assault – 3rd degree – special victim. Bond set at \$10,000 surety or 10% cash allowed. Parizo posted the required bond and released.

On June 11th, Andrew Ryan Derboven of Huntsville was served a Randolph County warrant for a probation violation on a class C felony charge of receiving stolen property. Bond set at \$25,000 cash only. Derboven remains in the Randolph County Jail in lieu of the required bond.

On June 12th, Jayson Michael Flowers of Hannibal was served a Randolph County warrant on an unclassified felony charge of fugitive from out of state. Bond set at \$10,000 cash only. Flowers was unable to post the required bond and was released to Illinois authorities.

On June 12th, Kyle Daniel Jones of Cairo was served a Randolph County warrant for failure to appear on a class C felony charge of receiving stolen property. Bond set at \$25,000 cash only. Jones remains in the Randolph County Jail in lieu of the required bond.

On June 12th, Rodger Antonio Harris of Moberly was served a Randolph County warrant on a class E felony charge of delivery of 35 grams or less of Marijuana or Synthetic Cannabinoid and a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid. Bond set at \$20,000 cash or surety. Harris posted the required bond and released.

On June 12th, William David Brittain of Moberly was served a Randolph County warrant for failure to appear on an unclassified misdemeanor charge of driving while revoked/suspended – 2nd or subsequent offense. Bond set at \$495.50 cash only. Brittain posted the required bond and released.

On June 12th, David Wade Asher of Armstrong was served three Randolph County warrants. Warrant one for a probation violation on a class D felony charge of resisting arrest/detention/stop by fleeing – creating a substantial risk of serious injury/death to any person and a class D felony charge of driving while revoked/suspended. Bond set at \$5,000 cash only. Warrant two for a probation violation on a class D felony charge of driving while revoked/suspended and a class D felony charge of resisting arrest/detention/stop by fleeing – creating a substantial risk of serious injury/death to any person. Bond set at \$5,000 cash only. Warrant three for failure to appear on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E

felony charge of driving while revoked/suspended. Bond set at \$5,000 cash only. Asher remains incarcerated.

On June 13th, Gregory A. Davis of Fulton was served a Randolph County warrant for failure to appear on a class C felony charge of burglary – 2nd degree. Bond set at \$492.57 cash only. Davis remains in the Randolph County Jail in lieu of the required bond.

On June 13th, Carl Johnson of Moberly was served a Randolph County warrant on a class B felony charge of violence to an employee of the Department of Corrections or to an inmate by an inmate. Bond set at \$20,000 cash only. Johnson remains incarcerated.

On June 13^{th} , Travis Allan Koenig of Moberly was served a Randolph County warrant on a class E felony charge of domestic assault – 3^{rd} degree and a class E felony charge of stalking – 1^{st} degree – 1^{st} offense. Bond set at \$5,000 cash or surety. Koenig posted the required bond and released.

On June 14th, Joshua Patrick Watkins of rural Moberly was served a Randolph County warrant on a class B felony charge of driving while intoxicated – habitual offender and a class E felony charge of driving while revoked/suspended. Bond set at \$30,000 cash only. Watkins remains incarcerated.

On June 14th, Tiana P. Perez of Moberly was served a Randolph County warrant for failure to appear on a class D felony charge of assault -3^{rd} degree - special victim and a class B misdemeanor charge of property damage -2^{nd} degree. Bond set at \$500 cash only. Perez posted the required bond and released.
